

People

There are many types of people that can be associated with an histology image: Creators, Contacts, Associated Parties, and Metadata Providers. At least one Creator and one Contact is required by EML, while Associated Parties and Metadata Providers are optional. All People share a similar form as shown below, except that an Associated Party has an additional **Role** field. The EML specification requires the specification of at least one of the following fields: Last Name, Organization, or Position Name.

MOTHER strongly recommends providing the first name and last name with organization for any person entered. For a scientist, it is also highly recommended to include their ORCID for unique identification. The MOTHER database currently stores the contact, metadata providers, and investigative personnel on a funding award associated with the image. The Web search displays the information for the contact.

At least one of the following is required: Last Name, Organization, or Position Name.

Creators

The creator is considered to be the owner of the image, i.e. the person(s) responsible for its creation. At least one creator is required.

Contacts

Include here people that researchers looking to use your data can reach out to. Ideally, you'll want to include the person responsible for managing the data. At least one contact is required.

Associated Parties

Associated parties can include lab technicians who performed work on the slides, lab assistants, other students or professors involved with the project, etc. Associated parties are not required. However, if specified, there is a required Role field, e.g. scanned slide.

Associated Party ?

At least one of the following is required: Last Name, Organization, or Position Name. Role is also required.
